RESOLUTION: Gratitude was expressed for the presentations, and it was decided to support the project *Caress the World*. Voted - unanimously.

QUESTION № 4: Presentation on the key results of the study *The Impact of IT on Sustainable Development* and the proposal to open IFSPD Branchin India. Report by Prof. SangeethVarghese, Ph.D., IFSPD Board of DirectorsMember.

RESOLUTION:The participants of the meeting pointed out the importance of research in the field of sustainable development, and highly appreciated the project implemented by Mr. S. Varghese. Voted - unanimously.

QUESTION № 5: Speechby Prof. Mehmet Akkan Suver, Ph.D. on the topic New Silk Road – the Dialogue of Civilizations.

RESOLUTION: It was decided to approve the list of the research projects, and to actively carry out the training and improvement of experts. Voted - unanimously.

QUESTION № 7: Consideration of educational research projects for teachers and students of the countries presented in the Foundation. Report by Prof. TarasFinikov, Ph.D.

RESOLUTION: Gratitude was extended to Prof. Finikov, Ph.D. for the proposals of educational projects for the countries represented in the Foundation, and stressed the commitment to implementation of projects in the field of education. Voted - unanimously.

QUESTION № 8:Consideration of the establishment of the International University for Peace and Development (UNIforP&D) in Istanbul. Report by Mr. Ismail Safi, Ph.D.,IFSPD Vice-President, and Prof. Murat Barkan, Ph.D.

RESOLUTION: Approve the proposed project and instruct Mr. Ismail Safi, Ph.D., Vice-President of IFSPD, to start negotiations with the relevant government bodies of the Republic of Turkey in order to create an

International University for Peace and Development in Istanbul, where IFSPD will be one of the founders.

QUESTION № 9: Establishment of the Ethical Codex. Report byAssoc. Prof. Dr. and Dr. Honoris Causa Sabahudin Hadzhialic

RESOLUTION: The report by Prof. Hadzhialic, Ph.D. on the need to establish a code of ethics for creating sustainable peace and development around the world was appreciated. Voted: majority.

QUESTION № 10: Modern Global Challenges and the Role of the State. Report by Mr. Vladimir Nikolayevich Plighin.

RESOLUTION: Gratitude was extended to Mr. V.N. Pligin for his report on this issue. Voted - majority.

QUESTION № 11: Presentation of the Anthology *TheTurkic World in Russian Poetry*. Report by Mr. Vyacheslav Samoshkin, IFSPD Associate Member.

RESOLUTION: The meeting participants took note of the information provided, and recommended to the members of the International Foundation to support this project. Voted - unanimously.

QUESTION № 12: Annual International Forum Russian-Turkic World: Response to Global Challenges. Report on the International Forum *New Alliance* based on the results of the Forum's work. Report by Mr. Mikhail Zernov, IFSPD Board of Directors Member.

RESOLUTION: The meeting participants highly appreciated the report of Mr. Zernov on this issue. Voted - unanimously.

QUESTION № 13:Consideration of the resignation of Mrs. Elmira Uygun from the position of Executive Director, appointing the new Executive-Director Ms. Esma Sirbubalo, and the resignation of Mr. Dimitrios Triantafillou from his membership in the IFSPD.

RESOLUTION: The resignation of Ms. Elmira Uygun from the position of the Executive Director of the IFSPD was accepted, and the participants of the Board expressed their gratitude to E. Uygun for her active work during the period of this position. Ms. Esma Sirbubalo was appointed as a new IFSPD Executive-Director. The application of Mr. Dimitrios Triantafillou for withdrawal from the IFSPD has been accepted. Voted - unanimously.

QUESTION № 14: Approval of the International Foundation for Sustainable Peace and Development Membership Certificate in the form of an electronic card. Report by Prof. Eldar Hasanov, Ph.D., IFSPD Vice-President and Secretary-General.

RESOLUTION: The International Foundation for Sustainable Peace and Development Membership Certificate in the form of an electronic card was approved. Voted - unanimously.

QUESTION № 15: Discussion of the venue for the 18th IFSPD General Assembly and theBoard of Directors Meetings.

RESOLUTION: The Secretary-General and the Secretariat of the International Foundation are instructed to consider proposals for holding the next meeting in Sarajevo (Bosnia and Herzegovina) or in Ohrid (Republic of North Macedonia). All members of the Board of Directors shall be informed about the results. Voted - unanimously.
