GUIDELINES FOR WRITING OF THE PAPER

We invite authors to submit a title and abstract of the paper until 19.11.2017. The title and the summary of the paper should be written in one of the official languages and in English language (14 pt bold). The summary should contain a brief answers on the questions: what were the motives / objectives of the research, what has been done, how it has been done, which are the main results and what is the significance of the results.

The answers summarized in a maximum of **150** and up to **200** words. Abstracts should be sent single column text, font Times New Roman, size 12, with line spacing of single row, the top margin 2.5 cm, and the rest with 2.5 cm.

Within the head of chapter abstract should be highlighted the title, the author's name and organization name, mailing address, telephone number, fax number and e-mail address. At the end of abstract should be listed up to five keywords. The abstract should be submitted in electronic form to the Organisational Committee at the following address: jasna.kuljanovic@gmail.com.

Jointly with the notification of acceptance of abstracts, authors will receive instructions for writing of the papers. Papers should be sent until **04.12.2017.** Submitted papers will be reviewed and the Organisational Committee will notify authors of acceptance of paper until **11.12.2017.** Accepted papares will be published in the Book of papers/Proceedings.
